Tiny Handz will make every attempt to ensure that the online training will be without any network problems from our side, as far as possible.</li> <li>I agree to the period of time (30 or 60 days) that will be given to complete the training that I am registered to complete.</li> <li>Should it be found that my access detail (Username and Password) is given out to other people and accessed by them, my training will be suspended with immediate effect and will not be renewed in future.
